EXPLANATION: Parties have a right under Section 908 (7) of the MPC to have a stenographic record made of the hearing. This usually requires that a court reporter be called in. If the parties waive the requirement of a stenographic record, the record of the hearing shall be kept on the municipality's sound recording system. If a party does not desire to waive this taking of the record by the stenographer, he/she shall so advise the Board prior to the hearing so that a stenographer can be arranged to be present. If not waived, applicant shall be responsible for one-half of all costs for providing of a stenographic record.
